State	Legality	Justification and Description
Alabama	Permitted	Alabama permits corporal punishment in public schools. ¹
Alaska	Prohibited	Alaska banned corporal punishment in public schools in 1989. ²
Arizona	Permitted	Arizona permits corporal punishment in public schools. ³
Arkansas	Permitted, w/ Disability Ban	Arkansas banned corporal punishment in public schools "on a child who is intellectually disabled, non-ambulatory, non-verbal, or autistic" in 2019.4

California	Prohibited	California banned corporal punishment in public schools in 1986. ⁵
Colorado	Prohibited	Colorado banned corporal punishment in public schools in 2023.6
Connecticut	Prohibited	Connecticut banned corporal punishment in public schools in 1989. ⁷ Although scholars have debated whether Connecticut's 1989 ban on maltreatment of children encompasses school corporal punishment, Sec. 53a-18 (6) enumerates when a teacher is permitted to use reasonable force to discipline a child and does not include school discipline, implying that corporal punishment is forbidden. ⁸
Delaware	Prohibited	Delaware banned corporal punishment in public schools in 2003.9
District of Columbia	Prohibited	The District of Columbia banned corporal punishment in public schools in 1977. ¹⁰
Florida	Permitted	Florida permits corporal punishment in public schools. ¹¹
Georgia	Permitted	Georgia permits corporal punishment in public schools. ¹²
Hawaii	Prohibited	Hawaii banned corporal punishment in public schools in 1973. ¹³
Idaho	Prohibited	Idaho banned corporal punishment in public schools in

Illinois	Prohibited	Illinois banned corporal punishment in public schools in 1993. ¹⁵
Indiana	Permitted	Indiana permits corporal punishment in public schools. ¹⁶
lowa	Prohibited	lowa banned corporal punishment in public schools in 1989. ¹⁷
Kansas	Permitted	Kansas permits corporal punishment in public schools. ¹⁸ Kansas law stipulates that with written permission school officials can apply corporal punishment to discipline students. ¹⁹
Kentucky	Prohibited	As of November 2023, every school district in Kentucky has prohibited corporal punishment. In August 2023, the Kentucky Department of Education required districts to create policies on school corporal punishment, and districts responded by banning the practice. Although state law does not prohibit corporal punishment in public schools, it is nevertheless illegal in the entire state. Department of Educations adopted by the Kentucky Department of Education prohibit corporal punishment on "students with an Individual Education Program (IEP) pursuant to 707 KAR Chapter 1, students with a 504 plan pursuant to Section 504 of the

Louisiana	Permitted, w/ Disability Ban	In 2017, Louisiana passed a law that stipulated "no form of corporal punishment shall be administered to a student with an exceptionality, excluding gifted and talented, as defined in R.S. 17:1942 or to a student who has been determined to be eligible for services under Section 504 of the Rehabilitation Act of 1973 and has an Individual Accommodation Plan." ²²
Maine	Prohibited	Maine prohibits corporal punishment in public schools. ²³
Maryland	Prohibited	Maryland banned corporal punishment in public schools in 1993. ²⁴
Massachuset ts	Prohibited	Massachusetts banned corporal punishment in public schools in 1971. ²⁵
Michigan	Prohibited	Michigan banned corporal punishment in public schools in 1989. ²⁶
Minnesota	Prohibited	Minnesota banned corporal punishment in public schools in 1989. ²⁷
Mississippi	Permitted, w/ Disability Ban	Mississippi banned corporal punishment on public school students with disabilities (defined as students with an IEP or Section 504 plan) in 2019. ²⁸

Montana	Prohibited	Montana banned corporal punishment in public schools in 1991. ³⁰
Nebraska	Prohibited	Nebraska banned corporal punishment in public schools in 1988. ³¹
Nevada	Prohibited	Nevada banned corporal punishment in public schools in 1993. ³²
New Hampshire	Prohibited	New Hampshire banned corporal punishment in public schools in 1983. ³³ New Hampshire also banned corporal punishment of children in state agency programs in 2021. ³⁴
New Jersey	Prohibited	New Jersey banned corporal punishment in public schools in 1867. ³⁵

Oklahoma	Permitted, w/ Disability Ban	In 2020, the Oklahoma Department of Education adopted regulations that prohibit "the application of corporal punishment to students with disabilities entitled to special education services under the IDEA." ⁴¹ In recent years, lawmakers in Oklahoma have attempted to codify this prohibition on the use of corporal punishment on students with disabilities in state law. ⁴²
Oregon	Prohibited	Oregon banned corporal punishment in public schools in 1989. ⁴³
Pennsylvania	Prohibited	Pennsylvania banned corporal punishment in public schools in 2005. ⁴⁴
Rhode Island	Prohibited	Rhode Island banned corporal punishment in public schools in 1977. ⁴⁵
South Carolina	Permitted	South Carolina permits corporal punishment in public schools. ⁴⁶
South Dakota	Permitted, w/ Disability Ban	South Dakota banned corporal punishment for public school students with "developmental disabilities." ⁴⁷ Gershoff and Font (2016) err in noting that South Dakota

Tennessee	Permitted, w/ Disability Ban	Tennessee prohibited corporal punishment for students with disabilities (defined as a "student who has an individualized education program (IEP) under the Individuals with Disabilities Education Act or a Section 504 plan under the Rehabilitation Act") in 2023 unless the student's parent provides written permission authorizing the practice on their child. ⁴⁹
Texas	Permitted	Texas permits corporal punishment in public schools. ⁵⁰
Utah	Prohibited	Utah banned corporal punishment in public schools in 1992. ⁵¹
Vermont	Prohibited	Vermont banned corporal punishment in public schools in 1985. ⁵²
Virginia	Prohibited	Virginia banned corporal punishment in public schools in 1989. ⁵³
Washington	Prohibited	Washington banned corporal punishment in public schools in 1993. ⁵⁴
West Virginia	Prohibited	West Virginia banned corporal punishment in public schools in 1994. ⁵⁵
Wisconsin	Prohibited	Wisconsin banned corporal punishment in public schools
